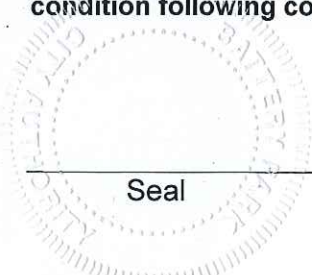

Permittee is hereby granted permission to use Nelson A. Rockefeller Park - North Lawn for recreational activities. All dates are subject to change/cancellation if conditions prohibit field playability. Permitted space not occupied by Downtown Little League cannot be designated for public use. Within these time brackets permittee agrees to abide by the following rules and guidelines set forth in this permit and satisfactory to BPCA Rules and Regulations appropriate to Permitting Practices, to insure satisfaction and professionalism throughout the season(s). **To protect the lawn; players must wear sneakers ONLY. Metal cleats, detachable cleats, and blade shaped cleats are prohibited. Permit subletting is prohibited and will result in a termination of any active permit(s).** Solicitation or collection of contributions, sale of tickets, refreshments or merchandise, sale distribution of handbills, posting, displays distribution of signs, and/or flyers advertising events or other materials are prohibited at all times. Neither BPCA nor BPCPC is responsible for personal, damaged or stolen property. Permittee agrees they're liable for any damage or injury to property and/or persons that may occur or be caused due to negligence during a permitted activity. **Downtown Little League is responsible for sweeping the lawn for trash and lost and found belongings following use of the lawn.** Permittee agrees that the safety of the public is of paramount importance and must be considerate of surrounding pedestrians at all time. Permittee agrees no portion of the lawn will be closed off to the public during their event(s). Permittee agrees to respect public's right to access all available area(s) of the premises during permitted period. **Permittee will not block designated pedestrian walkways and assure access for the BPC Parks Conservancy vehicle(s) at all times when needed. Permittee agrees to leave site in its original condition following construction period.** Permittee must carry their issued permit at all times.
